## UNAUDITED SALES DATA FOR JUNE 2025

In June 2025, the Group achieved contracted sales value of approximately RMB4.8 billion. The contracted area sold was approximately 165 thousand sq. m., with contracted average selling price of approximately RMB29,157 per sq. m..

As at the end of June 2025, the Group achieved contracted sales value of approximately RMB26.7 billion. The contracted area sold was approximately 961 thousand sq. m., with contracted average selling price of approximately RMB27,763 per sq. m..
